

BUILDING CONTROL CHARGES

Charges with effect from *1st April 2010*

The charges shown on this leaflet are **only** applicable to the **Havant Borough Council**

There are three tables of charges depending on the proposed work:

- a) **Table 1 NEW DWELLINGS**
- b) **Table 2 SMALL BUILDINGS, EXTENSIONS or ALTERATIONS**
- c) **Table 3 ANY OTHER WORK**

Where multiple works are proposed, i.e. extension and internal alterations, the separate charges should be added together.

FULL PLAN APPLICATIONS When submitting a full plans application you will pay the **plan** charge. We will send you an invoice for the **inspection** charge after works commence.

BUILDING NOTICE APPLICATIONS Plan charge and inspection charge are payable at deposit of application.

REGULARISATION APPLICATION To calculate the fee, take the Building Notice figure less VAT @ 17½% and add 20% to this figure (e.g. if the Building Notice charge is £139.80, the net figure is £118.98, add 20% = £142.77).

GENERAL NOTES

Value added tax is payable on all applications except for regularisations. (All figures are inclusive of VAT in Tables 1, 2 & 3).

Work which is solely to improve facilities for a disabled person on a domestic or public building will be exempt from charges.

If your work falls within the scope of Table 3 and is in excess of £100,000 please contact Havant Borough Council as in certain instances special arrangement for the payment of these charges are available. Charges are estimated in these instances by multiplying a reasonable number of hours taken to deal with the project, by the relevant hourly rates for staff involved.
