- 2) All charges in 2007/2008 include VAT where applicable. The VAT Code is per the list below.  
**S – Standard rate ( Currently 17.5%) N – Non business X – Exempt Z – Zero rated**
- 3) The charges marked “ Charges 2007/2008” will be effective from 1<sup>st</sup> April 2007 unless otherwise stated.
- 4) Any small scale rounding of figures to assist in the administration of collecting charges will be prepared by the officers as required.
- 5) Where concessionary charges are applicable it is intended that these will continue to be applied to those over 65 or in receipt of Housing or Council Tax benefit.

**VAT. LICENCES TO OCCUPY LAND; LETTING OF SPORTS FACILITIES**

Exemption from VAT may be applicable under the following circumstances:

**A.**      **Single lets**

Each single let is for a continuous period of over 24 hours to the same person, the person to whom they are let having exclusive control of the facilities throughout the let.

**OR**

**B**      **Series of lets**

**All** of the following criteria must be satisfied before exemption can apply:

- the series consists of 10 or more individual sessions of the same sport or activity, each session being in the same place: **and**
  - the interval between each session is at least a day and not more than 14 days : **and**
  - the series is to be paid for as a whole, and there is clear evidence of this, whether or not the right to use the facility for any specific
  - session is actually exercised A formal agreement, exchange of letters, or an invoice issued in advance requiring payment for the
  - sessions specified on the invoice would be sufficient evidence. Refund for the non-availability of the facility by the Council would not invalidate this condition but provision for a refund in other circumstances would; **and**
  - the facilities are let out to a school, club, association or organisation representing affiliated clubs or constituent associations; **and**
  - the person to whom the facilities are let has exclusive use of them during the sessions.
- It is not necessary to book the same pitch to qualify for exemption, provided it is within the same recreation ground. Any further bookings in addition to those specified in the formal agreement will be standard-rated and subject to VAT.

**VAT on Organised School Visits**

The letting of facilities to a local education authority school falls within these rules of exemption and is not outside the scope of VAT under the provisions of the Local Authorities (Goods and Services) Act 1970.

- A non-returnable deposit of 25%(to nearest £) is required for the advance booking of a hut with the balance payable 3 weeks before commencement of hire. If payment is not received within this period the hut will be eligible for re-let.
- Refunds on the full amount are only payable where the Council has been able to re-let the hut and medical evidence supports the claim.
- Advance bookings can be made from 1<sup>st</sup> January for the current year and cannot be made for periods of less than one week.
- Weekly lets commence at 2.00pm and terminate at noon on Saturdays.
- Each hut is equipped with 4 deck chairs, a table, broom, dustpan and brush.
- Sleeping in beach huts overnight is NOT permitted.

National Non-Domestic rates are also payable on Beach Huts and will be billed separately based on the Rateable value of the beach hut.  
Charges are reduced on a sliding scale for lettings proportionate to the time of year.

After determining which table the work your proposal falls into, you may calculate the charge payable. Where multiple works are proposed, i.e. extension and internal alterations, the separate charges should be added together. There are two methods of payment depending on the type and scale of work, i.e.

**FULL PLAN APPLICATIONS** The plan charge as shown in Tables 1-3 is payable when the application is deposited. We will send you an invoice for the inspection charge after works commence.

**BUILDING NOTICE APPLICATIONS** Under all tables the whole charge (plan plus inspection charge added together) is payable when an application is deposited.

**GENERAL**

**Value added tax is payable on all applications except for regularisations.** (VAT inclusive figures are shown in brackets in Tables 1,2 & 3).

Where a regularisation application is submitted the charge will be 120% of that stated in Tables 1,2 & 3.

The application may be exempt from charges if it is for work necessary to improve facilities for a disabled person, subject to certain criteria being met. A disabled person, whether registered or registerable, should supply supporting information with their Building Regulation application.
