Community Infrastructure Charging Schedule Review

CIL Draft Charging Schedule Consultation

Consultation on the Preliminary Draft Charging Schedule, which is the first stage in the preparation of a CIL charging schedule, took place in early 2018.

At this stage, unless you indicate you wish to appear at the examination you will not have the right to do so. Please note there is no guarantee you will be invited to the examination. The Inspector will decide who they wish to invite to each session. Any written representations will however, carry the same weight as any evidence presented at the Examination Hearings.
