Notes and definitions

It is ONS policy to publish subnational population projections presented in at least five-year age groups and rounded to at least the nearest hundred persons. Single year of age and/or unit-level figures are provided to enable further calculations, modelling and analysis under the open data agenda. The data in this file are rounded to three decimal places to facilitate production and may not sum exactly to aggregate totals. The projections are more robust at greater levels of aggregation, either by age or by area, as such we request that data are aggregated to at least five-year age groups and rounded to the nearest 100 people if quoted in any publication, presentation or documentation.

Long-term subnational population projections are an indication of the future trends in population by age and sex over the next 25 years. They are trend-based projections, which means assumptions for future levels of births, deaths and migration are based on observed levels mainly over the previous five years which are constrained at the national level to the principal national projections published on 6 November 2013. Projections show what the population will be if recent trends continue, but do not take

into account any policy changes that have not yet occurred, nor those that have not yet had an impact on observed trends.

The projected resident population of an area includes all people who usually live there, whatever their nationality. People moving into or out of the country are only included in the resident population if their total stay in that area is for 12 months or more, thus visitors and short-term migrants are not included. Armed forces stationed abroad are not included, but armed forces stationed within an area are included. Students are taken to be resident at their term-time address.

The projections do not take into account any policy changes that have not yet occurred, nor those that have not yet had an impact on observed trends. They are constrained at the national level to the national projections published on 6 November 2013, and are based on the 2012 mid-year population estimates published on 26 June 2013.

4.3.3 Assessment of accuracy by individual region

The remainder of this analysis considers the accuracy of the population projections at individual area level.

Table 6 shows that percentage differences between the population projections and population estimates for 2011 for each region in England. Across all regions, the 2010-based projections underprojected the population for 2011. All four sets of projections underprojected the population for 2011 in the North West, West Midlands, South East, and London. The 2004-based projections made the most significant underprojection for each

region.
