

Jubilee Park at Waterlooville Recreation Ground Car Park





ADDRESS: Jubilee Park at Waterlooville Recreation Ground Car Park, Milton Road, Waterlooville

LOCATION: The car park at Milton Road, near Anders Hall, Waterlooville

DESCRIPTION: This is a larger surfaced car park with approximately 61 spaces. Facilities nearby include Anders Hall and a playground. The Recreation Ground also benefits from a Bowls Club, Sports Club and tennis courts. Please note there is a height restriction barrier restriction of 2.1m (a key will be provided for the barrier).

Hampshire Farm Meadows Car Park





LOCATION: The car park is situated between the play park and the allotments.

The recreational facilities include a children's play area, Purbrook Heath Bowling Club, three hard surface tennis courts and a cricket ground. On the north side of the Road is a hospice and there is some residential to the west.
