**Havant Borough Local Plan  
Adoption Statement – Local Plan (Allocations)  
July 2014**

In accordance with the Town and Country Planning (Local Planning) (England) Regulations 2012 notice is hereby given that Havant Borough Council adopted the Havant Borough Local Plan (Allocations), July 2014 at a meeting of Council on 23 July 2014.

The Havant Borough Local Plan (Allocations), July 2014 forms part of the statutory Development Plan for the Borough and replaces the remaining Saved Policies from the Havant Borough District-Wide Local Plan. The Havant Borough Local Plan (Allocations), July 2014 follows on from the Havant Borough Local Plan (Core Strategy), March 2011. The main aim of the plan is to allocate land to help deliver the development requirements for housing and employment set out in the Core Strategy. It also includes a number of Development Management policies in addition to those in the Core Strategy.

Inspector, Sue Turner RIBA MRTPI IHBC BARCH MSC, an independent inspector appointed by the Secretary of State for Communities and Local Government, considered the Havant Borough Local Plan (Allocations): Submission Version, December 2013. Following public examination hearings held between 29 April and 1 May 2014, the Inspector's Report was received by the council on 7 July 2014. The Inspector found the Local Plan (Allocations): Submission Version to be sound, subject to a number of modifications pursuant to Section 23 of the Planning and Compulsory Purchase Act 2004. These modifications are set out in the Inspector's Report and accompanying appendix and have been incorporated in Havant Borough Local Plan (Allocations), July 2014.

Any person aggrieved by the Havant Borough Local Plan (Allocations), July 2014 may make an application to the High Court under Section 113 of the Planning and Compulsory Purchase Act 2004 on the grounds that the plan is not within the appropriate powers and/or a procedural requirement has not been complied with. Any such application must be made promptly, and in any event, no later than 11.59pm on 3 September 2014 (6 weeks after the date of adoption specified above).

The Inspector's Report and the Havant Borough Local Plan (Allocations) July 2014 are available to view at the Public Service Plaza (9am to 5pm Monday to Friday, excluding bank holidays).
